SPECIFIC PROCEDURES/Kev Qha/Qhia Tseeb Tseeb Txiv

1. Provision of information about program/Kev xaam/xam phaj

Written information sheets about the details of processing will be distributed in Wat Tham Krabok approximately **one week** prior to beginning registration. UNHCR, IOM, and U.S. government staff will also be available at Wat Tham Krabok to answer questions.

2. UNHCR registration/ UNHCR sau npe rua pej xeem suav dlawg/UNHCR sau npe rau pej xeem sawv daws

The purpose of the UNHCR registration is to obtain basic personal information. Applicants will have their photos taken. They will also be asked if they wish to be resettled in a third country. Persons who inform UNHCR during their registration interview that they are not interested in resettlement in the United States will be required to sign a statement to this effect.

If they fail to appear again, they will be sought out, counseled, and if they wish, be given a new interview date. If they do not appear for the newly scheduled interview date, they will lose their opportunity to participate in the U.S. resettlement program. If, after counseling, they state that they do not wish to participate in the program for U.S. resettlement, they will be asked to sign a statement to that effect.

There will also be announcement of the registration on the public address system **one day** before.

3. International Organization for Migration (IOM) drug test/IOM Kuaj kab yeeb, kab tshuaj

Immediately after the UNHCR registration is complete, applicants over the age of 14 will be asked to provide a urine sample for drug testing. The result will be known the same day and will be provided to the applicant. In those cases where the result is positive for drugs, a sample will be sent out for an additional test to confirm the positive finding. This second test will be final. Those for whom a positive test for drugs is confirmed will not be eligible to participate in the U.S. resettlement program.

6. International Organization for Migration (IOM) physical examination//IOM Kuaj Kev Muaj Mob Muaj Nkeeg

Physicians from the IOM will perform physical examinations of all those found eligible for admission to the United States. Generally speaking, if there are serious medical conditions, such as tuberculosis, they will have to be treated before travel to the United States. The Department of Homeland Security may grant a waiver for HIV/AIDS.

Applicants must bring the tracking document provided during the UNHCR registration and any medical documentation they have.

Lists of families, by their Thai registration numbers, to be examined on each day will be posted **one week** in advance at the processing site and throughout Tham Krabok prior to the examination. There will also be announcements on the public address system **one day** before.

7. International Organization for Migration (IOM) cultural orientation/Qha kev cai moog nyob teb chaws tshab

The purpose of the IOM cultural orientation is to prepare those found eligible for admission for their new life in the U.S. and their long journey ahead. The cultural orientation will last one week and include some basic English training.

For those found eligible for admission to the United States, IOM will organize transportation by bus from Wat Tham Krabok to Bangkok International Airport and by airplane from Bangkok to the United States.
